Endangered Species in Central Laos are Under Threat by Nam Theun 2 Dam

13 Species of Globally Endangered Animals are being Threatened

Habitats of endangered species in the Nakai Plateau of central Laos are now being threatened by the Nam Theun 2 Hydroelectric Project, for which the World Bank and Asian Development Bank are considering providing risk guarantees and financing.

The reservoir of the proposed Nam Theun 2 Hydroelectric Project would flood 450 square kilometers--40 percent of the Nakai Plateau-- and "degrade" another 500 square kilometers. It will inundate habitat for 60 species of birds and mammals and disrupt migration routes. The area is home to a large variety of rare and endangered plant and animal species, including Asian elephants. white-winged Duck, and Saola, one of the rarest large mammals in the world.

Asian Elephants and Nam Theun 2 Dam

A large population of wild Asian globally elephants. which are endangered, lives on the Nakai Plateau. According to the advanced draft of the Nam Theun Environmental Assessment Management Plan (EAMP), the most recent estimate shows at least 120 elephants--approximately ten percent of the total elephant population in Laos--live in one of the subpopulations inhabiting the Nakai Plateau. Another large sub-population living on the plateau has never been surveyed, thus the total number of elephants living on the Nakai Plateau is unknown.

The dam's construction would inundate and degrade almost all mineral licks and large areas of forests and grasslands that are essential habitat for the Nakai elephants. According to Premrudee Daoroung of Bangkok-based Terra (Towards Ecological Recovery and Regional Alliance), however, the World Bank and Nam Theun 2 Power Company have yet to disclose the impact on elephant herds living on the plateau.

What is the Nam Theun 2?

The Nam Theun 2 dam is an internationally controversial large dam project which the World Bank is considering for funding. It is expected to relocate approximately 6,000 people and impact the livelihoods of 100,000 more. The budget of the project is 1.2 billion dollars, equivalent to 70% of the GDP of Laos. Seventy percent of revenues are expected to come from overseas donors, and whether or not enough financing can be assembled depends largely on the decision by the World Bank. If the World Bank does make a final decision to finance the project, it will provide a "stamp of approval" which will encourage private banks charging high interest rates to invest in already heavily indebted Laos. In addition to the environmental and social risks, the project also brings great economic risks.

Help save the endangered animals of the Nakai Plateau!

If the World Bank and Asian Development Bank do not provide risk guarantees and funding for the proposed Nam Theun 2 Hydroelectric Project, the project will probably never be built. Then conservation of the Nakai Plateau and habitats of endangered species can begin.
