- LSP will apply a competitive bidding process to select those MFIs that can not only deliver the lowest interest rate possible for outreach, but can also partner with NGOs who can provide corollary training services. The key objective of the proposed LSP will be to enable poor households to generate income to service their loans at a later stage. Consequently, the grant element of the LSP will support those beneficiaries who pursue livelihood training that will help them escape the poverty trap. This process will ensure the most favorable terms and conditions for the poor people, while maintaining the sustainability, integrity, and viability features that are critical for a project of this nature to the poor people at the most concessional rates of interest and terms possible to enable support livelihood enhancement.
